EVERY HORSE ADMITTED ONTO THE GROUNDS MUST FIRST PROVIDE AT THE STABLE GATE A CURRENT HEALTH CERTIFICATE ISSUED WITHIN 30 DAYS OF ARRIVAL AT THE TRACK WHICH SHOWS THE VACCINATION RECORD OF EACH HORSE. THE HORSE MUST HAVE BEEN VACCINATED WITH AN FDA APPROVED MODIFIED LIVE OR KILLED VIRUS VACCINE FOR EHV-1 NOT LESS THAN 14 DAYS PRIOR TO THE ENTRY DATE AT THE RACETRACK AND NOT MORE THAN 90 DAYS PRIOR TO THE DATE OF ENTRY. A BOOSTER VACCINE WILL BE REQUIRED WITHIN 10 DAYS FOR ANY HORSE ADMITTED ONTO THE GROUNDS AT SUCH TIME THAT A HORSE'S VACCINATION RECORD INDICATES THE MOST CURRENT VACCINATION WAS MORE THAN 90 DAYS PRIOR.

- Q: Do I need to call and check to see if I got stalls?**  
**A:** No, if you submitted your application and are awarded stalls we will call you. There is no deadline to apply for space.
- Q: When can I ship in?**  
**A:** Not before we call you. The track opens for training February 1 with a limited schedule due to construction. A limited number of stalls will be made available January 10. The Equicizer will be available for use through that month.
- Q: What do I need to bring with my horses?**  
**A:** An original negative Coggins and a valid health certificate.
- Q: Will I get stalls if I owe money to WRD? I also plan to fax my application and park on the grass, is that okay?**  
**A:** No to all three. Please mail or submit an original application.
- Q: Can I be back where I was last year?**

**STALL SPACE APPLICATION  
TERMS AND CONDITIONS**

Please Read Carefully

As a condition of the acceptance of this application, it is mutually agreed upon and understood that applicant ("Applicant") and all persons for whom he/she is acting will be bound by the terms and conditions of this stall application as set forth below and the Applicant represents that he/she has been granted the appropriate authority by all owners of the horses in the care of the Applicant to make this application and to agree to its terms and conditions and to bind such owner(s) to the same.

1. Will Rogers Downs, LLC ("Racetrack") reserves the right to refuse the application for stable space in whole or in part or refuse the acceptance of any entry into any race for any reason or cause and without notice to the undersigned.

2. All disputes, claims and publications arising out of the racing at this venue or with respect to the interpretation of any rules or conditions of races, or otherwise, shall be decided by the Oklahoma Horse Racing Commission, the Stewards of the meeting or track management as the case may be, and such decisions upon all points shall be final.

3. **Stabling Qualifications:** The following horses will NOT be eligible for stabling:

A. Horses that have started for a claiming price of \$2,500 or less AND HAVE NOT WON for a claiming price of \$2,500 or more since then.

B. Horses that have never won two races AND have started for a claiming price of \$3,000 or less.

C. Maidens that have started for a claiming price of LESS THAN \$5,000. Additionally, maidens over the age of five (5) must have competed in a pari-mutuel race WITHIN 18 MONTHS of the date for which you are entering to run.

D. Horses less than THREE years of age. Due to limited space, two-year-olds will NOT be permitted to stable here during the meet.

4. The granting of stall space is for the purpose of assuring the availability of horses which, in the sole opinion of management, will produce our best racing product. Due to limited space, some requests will be denied. Pony stalls will be allocated on an individual basis with preference to trainers who are assigned at least 16 stalls. If you would like a pony stall, please list so on your application. It is understood and agreed upon that the granting or denial of stall space is at the sole discretion of the Racing Secretary and management.

5. **Stable Area:** A) No dogs will be permitted in the stable area. B) No smoking is permitted inside any enclosed barn, under shed rows, in an open barn or in any tack rooms. C) No sleeping or cooking is allowed in the tack rooms. (Microwaves and coffee pots are allowed.) D) Bagged sawdust, wood shavings and wood chips are allowed. **Management must approve any bulk shavings and other bedding.** All discarded bedding must be placed in the concrete bunkers provided. E) Only the track's rental hot walkers are permitted. F) All hoses located in the stable area must have an automatic shut-off nozzle and shall be turned off when not in use. G) Only biodegradable soap may be used. H) Management must approve any structures, stationary or temporary, prior to construction. I) Use of infrared heat lamps is prohibited. J) It is the sole responsibility of the trainers and their employees to maintain a clean and neat barn area. Stalls are subject to inspection and trainers will be subject to eviction if stalls are found to be in unacceptable condition. **TRAINERS LEAVING STALLS DIRTY WHEN VACATING WILL BE CHARGED \$20 PER STALL FOR CLEANUP.**

6. **Dorm Rooms:** A) Trainers may be permitted to install surveillance cameras for employees will be required to pay an UP FRONT DEPOSIT of \$150 per room. The deposit is refundable upon the space being properly cleaned and approved by a WRD racing employee. B) Trainers must furnish the names of employees occupying dorm rooms along with their contact information. C) No minor will be issued a room without an attending adult. D) Dorm rooms are for OHRC licensees only. E) Please indicate your dorm room needs on your application.

7. **Barn Cameras:** Trainers may be permitted to install surveillance cameras in their barns WITH PRIOR APPROVAL. You must request permission on your stall application. Trainers with barn cameras will be kept on file with the WRD surveillance department and must keep any and all cameras pointed only in the direction of their own stalls and shed rows.

8. **Miscellaneous:** Stalls will not be reserved for horses other than those on your approval list. If you obtain other horses at a later date, subsequent stall approval will be required by the Racing Secretary before shipping in. The Applicant agrees to abide by and comply with all rules and regulations of the Oklahoma Horse Racing Commission and Will Rogers Downs. The track may televise, authorize or license the televising of horse racing conducted at Will Rogers Downs and accordingly hereby reserves television rights whether in connection with any race, preparations therefore or ceremonies or proceedings thereafter or training at the track. This application is accepted on the condition that, if the licensee's horse comes within the range of the television camera, that licensee will sign and deliver releases to track management permitting such television footage and the exhibition thereof. If stall space is granted, the Applicant, owner, his or her trainer acting as agent of owner (when the application is signed by the trainer) or any other duly authorized agent acknowledges that the Applicant shall be a licensee upon the grounds of the track and the authorization granted for the stabling of horses shall be revocable at any time. Applicant acknowledges that Will Rogers Downs assumes no liability for loss by fire, any other acts of nature, theft of any equipment or property of horsemen or any accident occurring on the grounds. Owners and/or trainers will be held liable for any misuse of the stall and dorm rooms assigned to them and for conduct of their employees on the grounds. By offer of this application, the owner and/or trainer agrees to indemnify and hold harmless Will Rogers Downs, LLC, its officers, agents and employees from any and all liability, claims, judgments, sum of money, legal fees, court costs, and investigative expenses that may be incurred for or on behalf of the track, its officers, agents or employees in defense of any such liabilities or obligations arising out of any act performed or committed by the Applicant, trainer, owner, their agents and/or animals. Any trainer that intends to bring a horse on the grounds must have minimum workman's compensation on file with OHRC BEFORE doing so if they have employees.
